## What is the Arizona School Tax Credit Program?

The **Arizona School Tax Credit** Program allows you to direct your state income tax payment to public schools for extracurricular activities. Taxpayers may direct up to \$200.00 per single taxpayer or \$400.00 per married couples filing jointly to public schools. At **Mountain Oak School**, these funds provide extracurricular activities such as:

- Stringed Instrument Lessons
- Woodworking
- Percussion
- Foreign Language Instruction (Spanish)
- Handwork
- After-School Programs/Sports
- Folkband & More

It's simple - the money you donate to the school's Tax Credit Program replaces dollar-for-dollar what you owe in the state income taxes!

Keep your receipt received from the school. The dollar amount donated may then be subtracted from the total amount owed in state income tax.
