## **ENROLLMENTCONTRACT**

Program fees must be paid within 5 days of the beginning of each month. There is no reduction for shortened months or refunds for days missed.

Tuition installments are due and payable on the first day of each month and must be received by Mountain Oak School no later than the fifth (5<sup>th</sup>) of each billing month. A late charge of \$25 will be assessed against each late or returned payment for each month the payment is late.
