Saturday, we had a dozen people at the school from 9-2 planting \$700 worth of plants, soil, and fertilizer that we got from Prescott Valley Nursery for about \$350. We had fall picture day. Lantern walk was beautiful. We over-filled the parking lot at Lynx Lake. Our next event is the Winter Spiral scheduled for December 16th at 5:00. Planning is complete, but work has just begun.
