#### Public Comments - May 3, 2022 Board Meeting - DRAFT IN PROGRESS

**Frank Coe** – Son in 5<sup>th</sup> grade w/ Mr. Cal. My comments are regarding your recent actions in essence as a leadership team you have perceptually and effectively walked into a crowded room, dropped a grenade, walked away and watch everybody scramble. Blatant disregard to the ramifications to both children and parents. Not sure if part of your calculus or not, but either way, shame on you guys. This was highly unproductive. It was disruptive and unprofessional. In addition, we submitted a letter with significant parent representation that was also ignored, which as a concerned parent is also completely unacceptable. There hasn't been a modicum of integrity or consideration demonstrated by this board.

Lastly, in the spirit of transparency will you provide a copy of the bylaws and the charter.

Response: Bylaws and charter documents are available in the office.

**Jeff Elmer** – Holding children out of school until resolution from board and leadership of MOS. Not just the board, but even the teachers, it has created a hostile environment for children and teachers (dropped from Zoom)Looking for – Hold kids out until that meting – Disfunctional mess. Don't trust leadership – Move forward. (Leaving 2 children)

**Jamie Wilcox** – 5-6 years at school except for Covid year. So many of us don't know what has been going on in ES and conversations. Most significant concern - absence of transparency / how many minutes spent in Executive Session (ES), etc. We are the parents we want to be part of this community want to do everything we can – included to be part & volunteer. Reflection of hearts and passion. When not included with conversation, such as why was director fired. Not an example, ride out the year. Transparency is the most important thing to live, be & model for these children.

**Victoria Ellis** – I appreciate that answer (above), Craig. I think speaking for myself, part of what felt like there was no transparency was that multiple teachers, parents and staff members seemed to know of a decision that I though was only supposed to discussed in ES. How is that okay? If not legal to discuss, so how did so many people know to the point that the hostile environment exacerbate on Friday, throwing it around. How is that okay?

Response - BM – we are not discussing these items, and likely people did not "know". However, people may be seeing agendas, etc. and reading between the lines and making assumptions and running with it. We do not have control over that unless it is an employee, and it is brought to our attention.

To clarify, some things were thrown around prior to the agenda.

CM – The board has to come out of ES to vote. Board does not meet in a quorum (3 people) If employee or someone said something, please write a letter to the board. People deduce things from previous meetings and what they have heard.

**BM** – May or may not be accurate deductions.

VE - How do we trust? How do we know we can trust you?

**BM** – Perhaps Community Forum will help. We are here because we care about school. We have had a lot of challenges and COVID, trying to navigate p Waldorf Illumination this year and want to align more to Mission and Vision – Waldorf Education nights – People love the school and hope to move forward and earn trust.

CL – Encouraged people to look at agendas and come to meetings if interested.

CR - Send out meeting agendas through Parent Square.

**Jessica Garbett** – Lots to talk about. Letter from parents with no acknowledgement of letter or feedback. Friday was kids day to shine. Having meeting that day, impacted the children and parents, couldn't it have waited until the end of the year. Caused instability. This could cost our school because people are looking at other schools because of this. Serious. Not sure you understand.

#### Response

CL - Receive letter 20 minutes before meeting started. Did not have time to digest before the meeting.

BM - No public comment on meeting agenda

CR – Some things in the letter we can answer again, but hope that some of the items were clarified during meeting today.

**CL** – Board as a function of the economics and budget of school is highly concerned with anything that affects enrollment of the school. Stressed importance of part of board's mission to maintain existence of the school

**Jessica Garbett** – Board didn't answer questions. Toxic environment to staff and kids, mama and papa bears. Board is talking, but nothing coming out. By not answering, show her direction to go next year.

**CM** – We are bound by state laws. Direction of school is our focus. We have to operate with in the boundaries of the law. Protection of employees of the school.

**Mikayla Newell** – Why it couldn't work 4 weeks? Kids are out of school. Lost multiple teachers in the middle of the year. Hurting her child. To have teachers pulled hurts her. So much turnover, something wrong. Love school.

#### Response

BM - We did not remove any teachers. We removed one person. Anyone else that left did so on their own accord.

**CR** – We hear your questions, but we cannot answer lawfully.
