




What afterschool programs would you like to see available? 43 responses



Do you feel \$700 per month is a fair price for our Preschool program? 35 responses




Would you make use of a fee-based breakfast and lunch program? 43 responses




Would you make use of a free breakfast and lunch program if offered through the National School Lunch Program?



Would you utilize a carpool drop-off point? (Sharing rides with other parents) 42 responses


