Mountain Oak plans to stay in person learning unless otherwise required by federal guidelines. Students who are home due to COVID related illness or quarantine are given homework by the teacher, emails for questions of teachers, and not penalized due to time missed due to COVID related absences.

Students' Needs:				
Academic Needs	We have Weekly academic clubs and tutoring, a Title I math and reading teacher to help with learning loss, and instructional aids in classrooms over 20 to help with direct assistance.			
Social, Emotional and Mental Health Needs	We have an Eco Therapist who teaches gardening, an Art Therapy teacher who works one on one with students referred by teachers and or parents, and a Reading Therapist to assist kids with extra assistance in assessing and working through reading struggles in our older readers 4-8. Our school counselor is available for walk in sessions.			
Other Needs (which may include student health and food services)	Mountain Oak is planning to start a breakfast, lunch, and snack program here at our school in our school kitchen that coordinates with local growers in a farm to table program. Our goal is to feed all children with no cost to families who are struggling.			
Staff Needs:				
Social, Emotional and Mental Health Needs	If staff feels the need to take time off for social, emotional, or health needs, we will provide a substitute. We are hoping our food program will additionally support the staff's social, emotional, mental, and health needs as we will provide food to staff at minimal cost.			
Other Needs	Our campus is cleaned and sanitized with steam and other natural methods that are safe to our stakeholders, and effective at disinfecting our campus. This cleaning takes place Monday-Friday across campus by a professional cleaning company.

# U.S. Department of Education Interim Final Rule (IFR)



#### (1) LEA Plan for Safe Return to In-Person Instruction and Continuity of Services

- (a) An LEA must describe in its plan under section 2001(i)(1) of the ARP Act for the safe return to in-person instruction and continuity of services—
  - (i) how it will maintain the health and safety of students, educators, and other staff and the extent to which it has adopted policies, and a description of any such policies, on each of the following safety recommendations established by the CDC:
    - (A) Universal and correct wearing of masks.
    - (B) Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding)
    - (C) Handwashing and respiratory etiquette.
    - (D) Cleaning and maintaining healthy facilities, including improving ventilation.
    - (E) Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments.
    - (F) Diagnostic and screening testing.
    - (G) Efforts to provide vaccinations to school communities.
    - (H) Appropriate accommodations for children with disabilities with respect to health and safety policies.
    - (I) Coordination with State and local health officials.
  - (ii) how it will ensure continuity of services, including but not limited to services to address students' academic needs and students' and staff social, emotional, mental health, and other needs, which may include student health and food services.

(b)(i) During the period of the ARP ESSER award established in section Start Printed Page 212022001(a) of the ARP Act, an LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in-person instruction and continuity of services.

- (ii) In determining whether revisions are necessary, and in making any revisions, the LEA must seek public input and take such input into account
- (iii) If at the time the LEA revises its plan the CDC has updated its guidance on reopening schools, the revised plan must address the extent to which the LEA has adopted policies, and describe any such policies, for each of the updated safety recommendations.

#### **Current Practices & Protocols:**

- Mountain Oak is holding in person school, on campus, every school day. Remote learning will be considered
  only in the event of closure.
- All eligible people are encouraged to be vaccinated against COVID-19, per public health advice.
- Masks are optional for students indoors.
- Anyone who has any symptom of illness must stay home. This is the key to prevention.
- Ventilation in the building is optimized through HVAC settings, air filters, and open windows.
- Upper and Lower grades are separate indoors, but may spend time outside as reading buddies.
- Access to the building and campus during the school day will be limited to faculty, students, and others only
  as invited onto the campus for official and professional purposes and parents who give prior notice, they are
  visiting a class.
- Student desks are socially distant at 3 feet apart. -We will practice good hand hygiene and respiratory etiquette.
- We continue to clean surfaces regularly.
- A cleaning company comes Monday Friday to clean and sanitize surfaces and highly frequented areas.
- We continue to work collaboratively with the Local Health Department, and follow their instructions.
- Parents of a class where a positive case has been confirmed will be notified and any one deemed in "close contact" as defined by the Yavapai County Health Dept.
